CONDITIONS:

- This licence is only for private security agency work. This does not grant any permission to engage in intelligence collection, detective agency work or any other such activities.
- Validity of Licence is for the period of five years from the date of issue unless mentioned otherwise.
- The licencee shall commence his/her business within 6 months from the date of issue of Licence (Sec 9 of PSAR Act).
- The licencee/firm shall comply with the provisions of State Insurance/EPF/GST etc. as per the existing rules/law.
- The licencee/firms shall ensure that guards and supervisors undergo the required training as per the provisions of PSAR Act 2005 (Standing Order No. II* date 10.02.2017 issued by this Department shall be compiled with strictly).

- Police verification of guards and supervisors will be the responsibility of licencee/Firms.
- As per rule 9 of PSAR Act 2005, Medical Examination after every 12 months for guards and superviors is 6. compulsory and a Specimen Certificate to that effect is attached. (To be read with the Standing Order 7. no. II* dated 10.02.2017 of Controlling Authority) The Licencee /Firms shall provide list of Security guards, their training certificates and their medical examination as per standing order mentioned above. Licencee/Firms shall apply for renewal of Licence on or before 45 days of expiry of his/its Licence.
- The Original Licence shall be deposited with this office on Expiry of Licence or on closing of Security 8.
 - This License is valid for providing security guards only as per the provision of PSAR Act, 2005 and
- The provisions of the Schedule of section 13 (j) of the Private Security Agencies (Regulation) Act- 2005 9. shall be followed.
- in case of any litigation jurisdiction shall be Jalpur city only. 10.
- The Licencee shall ensure enlisting 25% of the total strength from duly trained Home Guard Volunteers. 11.

- In case of non observance/non compliance of above mentioned conditions the Licence issued hereunder shall be liable to be cancelled and punitive/criminal action may also be initiated. N.B:-
- The Licencee shall ensure compliance of all relevant provision of PSAR Act 2005 & RPSA (Regulation) Rules -2006 as stated in the advisory issued by Controlling Authority on 15.06.2020 (Copy attached) 13.
